


# Dealership Insights | eSign and Electronic Statement

In Dealer Use Only. Not for Customer Use.

**What is eSign?** In order for Goldman Sachs Bank USA to send documents, such as statements and important account information to customers electronically, customers are asked to opt-in to an eSign Agreement during the application process. As part of the application process to receive a My GM Rewards Mastercard, the customer must opt in to eSign. It is also important that they read the Agreement prior to completing their application.
